Entry to the Contest (defined below) is open only to passengers traveling to Hyderabad or out of Hyderabad through the International Airport. 4. Each participant to the Contest ("participant") must be above the age of 21 years or the legal drinking age as defined by the applicable regulations of the Participant's country or state of residence, whichever is higher. 5.
